#### This Month's Priorities

- GPRO: Our 2020 GPRO reporting will begin January 4th and end March 31st. We ask everyone for their continued cooperation, working with our teams to provide the data and documentation needed for another successful reporting period. Each practice/organization has been asked to identify a point person, and they will be receiving communications throughout the reporting period.
- 2. MIPS APM Promoting Interoperability Reporting: During the January 4th-March 31st reporting period each TIN must report their Promoting Interoperability(PI) data directly to CMS utilizing their QPP Portal Account as part of their ACO participation for 2020. James Renner has been working with your teams to review reporting and/or hardship applications as appropriate. You will select your best 90 day consecutive reporting period from 2020 to report.
- 3. QRDA 3 EMR Quality Reports: Beginning in 2021 and mandated in 2022 ACOs will need to adjust how we report our quality metrics. In preparation for this change we are asking that all practices run a QRDA3 report from their EMR for 2020. Once you have done this please notify *Brian Pinga* and he will work with you to set up a review of the report and/or provide additional guidance as needed.

## Our 2019 MIPS score has yielded us a +1.59% payment adjustment in 2021

IHANY's 2019 MIPS (Merit Based Incentive Payment System) score was **97.05/100**. The score reflects our combined performance in Quality (50/50 for the second year in a row!) and Promoting Interoperability (23.37/30). In addition CMS recognized MSSP participation by awarding full credit for the Improvement Activity

category (20/20) and the complexity of patients we serve through bonus points (3.68/5.00).

IHANY's MIPS score translated into a 1.59% positive payment adjustment that will be applied starting in January 2021. Thanks to all for another great performance year and for working together in 2020 to improve our Promoting Interoperability score.

## **CMS Billing Update**

# Medicare FFS Claims: 2% Payment Adjustment (Sequestration) Suspended Through March

The Coronavirus Aid, Relief, and Economic Security (CARES) Act suspended the payment adjustment percentage of 2% applied to all Medicare Fee-For-Service (FFS) claims from May 1 through December 31. The Consolidated Appropriations Act, 2021, signed into law on December 27, extends the suspension period to March 31, 2021. (CMS MLN Network notification, 12/28/20).
